

The Golisano Autism Center to be built in Rochester



Innovative Collaborative Model will Serve Thousands with Autism



CP Rochester, AI Sigi Community of Agencies, and AutismUp announced they are collaborating to build a new Golisano Autism Center Rochester, which will expand and enhance autism services to serve the more than 10,000 people diagnosed with autism in the Greater Rochester and surrounding areas. The new Center will be named for philanthropist, Paychex and Golisano Foundation Chairman, **Tom Golisano, who announced that he is making a matching challenge grant of \$2.5 million to help build the Center.** The Golisano Autism Center Rochester will be located on South Avenue near Science Parkway and will include shared program spaces, a sensory gym, classrooms, therapy rooms and more. The total cost of construction for the 25,000 square foot building is \$4.8 million. Ground breaking is expected to commence in the fall of 2017 and opening is targeted for fall 2018.

Golisano said, "I am pleased to provide a challenge grant of \$2.5 million to help build this unique collaborative center, which will bring together a wide array of coordinated services and expertise under one roof. The Center will represent a significant improvement in how people with autism and their families can get the services they need over the course of their lifetimes. I hope that my gift will inspire others to join me and contribute in a meaningful way to this important endeavor." **The first major gift toward the anticipated two-year challenge comes from the Golisano Foundation in the amount of \$500,000, making the total commitment-to-date \$3 million.**

New Center Will Transform Autism Services

The establishment of the Golisano Autism Center Rochester will transform the delivery of autism services by colocating and coordinating resources offered by multiple autism providers, each of which offers specialized areas of expertise. This comprehensive, enriched and innovative model emphasizes collaboration amongst complimentary autism-specific programs in the community. The proximity of the Center to related medical services will insure ease of access for thousands of families seeking autism services.

The Golisano Autism Center Rochester will provide a continuum of services that span a lifetime and offer a full array of coordinated program options for infants, toddlers, youth, teens and adults including, but not limited to: behavioral and primary care supports; respite; community habilitation; social, recreational and therapeutic services; housing and employment liaisons. High quality, evidence-based school-age instruction, developed specifically for individuals with autism, will be provided by Mary Cariola Children's Center. Lead partners CP Rochester, AI Sigi Community of Agencies, and AutismUp will coordinate the addition of other affiliate autism service agencies to be housed at the Center.

"The Foundation and Tom's investment in the Golisano Autism Center Rochester will have a long-lasting impact on individuals with autism, their families and the entire community," says Ann Costello, Golisano Foundation Director.

According to the Centers for Disease Control, one in 68 has been identified with autism spectrum disorder (ASD). ASD is a life-long developmental disability diagnosed between ages two to five that impacts communication, interaction, behaviors and learning in different ways, and requires a unique approach to support services. The prevalence has grown at such an alarming rate that it has produced a significant gap in coordinated services for individuals and families.

"Our heartfelt thanks to Tom Golisano, Ann Costello and the Golisano Foundation Board of Trustees for believing in our vision to support the enhancement and expansion of autism services in our community." adds Mary Walsh Boatfield, President and CEO of CP Rochester.

Dr. Elmar Frangenberg Earns 2017 Health Care Achievement Award

CP Rochester and Happiness House Medical Director, Dr. Elmar Frangenberg, has spent close to 45 years working with the developmentally disabled and was recognized as the recipient of a Health Care Achievement Award in the Special Needs category by the Rochester Business Journal (RBJ). Each year, RBJ honors three winners in each of eight categories: Health Care Staff, Innovation, Management, Nurse, Physician, Senior Care, Special Needs, and Volunteer.



Dr. Frangenberg has been Medical Director for CP Rochester (CP) part time for the past 37 years and in January 2017, assumed that role at Happiness House (HH). In addition to his positions at CP and HH, Frangenberg worked as full-time Medical Director for Monroe Developmental Center (MDC) up until 2003, after close to 30 years. He continues to work part-time at MDC as a physician in the geriatric assessment clinic. Frangenberg is also a clinical assistant professor in the University of Rochester School of Medicine and Dentistry's (URSMD) neurology department. It was during Frangenberg's post-graduate work through URSMD as a resident that he first interacted with the developmentally disabled. "I was really intrigued by my visits, as a neurology resident," Frangenberg said. After completing his medical training, Frangenberg was recruited to join MDC.

Dr. Frangenberg developed a passion for working with and treating those with developmental disabilities and this passion has earned him praise from his peers. "Dr. Frangenberg is a tremendous asset to each of the organizations he works with -- CP Rochester and Happiness House," said Mary Walsh Boatfield, President and CEO of CP Rochester, Happiness House, and Rochester Rehabilitation. "His clinical experience, compassion, keen insights and ability to successfully interact with a broad range of individuals, including staff, families, individuals with special needs, and clinical professionals, make him an invaluable resource."

Many of our Traumatic Brain Injury (TBI) program participants shared their stories in videos that were posted on Facebook. Living with a TBI is sometimes frustrating and challenging, but each of our participants found help. They are all participants in TBI programs at Happiness House. Engaging in activities, seeking assistance through supportive programs, and being patient with themselves and others allows those living with TBI to be their best. Happiness House offers programs to help those with TBI maintain or improve one's ability to live in the community, including:

- Independent Living Skills Training (ILST)
- Home & Community Support Services (HCSS)
- Service Coordination
- Community Integration Counseling (CIC)
- Positive Behavior Intervention Services (PBIS)
- Structured Day Program
- STEPS to Independent Living Program

CP Rochester offers clinic services and Rochester Rehabilitation offers employment programs for those with TBI.

\$10,000 Awarded to CP Rochester for Lift Free Technology

\$240,000 Gifted from Golisano Foundation for Transitional Apartments

In October 2014, Golisano Foundation gave CP Rochester a grant of \$40K to begin preliminary work (architect drawings, engineering studies, etc.), on development of Transitional Apartments to be located on Pinnacle Road in Henrietta, New York. At that time they pledged another \$200K when we were closer to doing construction. In February 2017, CP Rochester received the remaining \$200K for building renovations to the 'transitional apartments' for young adults with disabilities. Rather than construct a new building for the transitional apartments, CP Rochester plans to renovate a former Individualized Residential Alternative building located on Pinnacle Road currently owned by the Al Sigl Community of Agencies.

"We applaud CP Rochester's vision to create a transitional residence for young adults with disabilities who, with appropriate support, are capable of learning the skills necessary for independent living," said Ann Costello, Executive Director of the Golisano Foundation.

"There is an urgent need for young adults with physical, cognitive, and developmental disabilities, including autism, to access community-based housing and begin the transition from living with families and caregivers to building a life for themselves within the community," said Mary Walsh Boatfield, President and CEO of CP Rochester. "These individuals have a strong desire to pursue and create their own plan for community housing."

The design and function of CP Rochester's transitional apartments will closely mirror the successful transitional apartments constructed by Happiness House in Canandaigua, which were funded in large part by the Golisano Foundation. The Happiness House transitional apartments, which opened in 2012, were created to be a stepping stone for individuals with a disability as they moved from living with family or in a certified setting, to living independently in the community of their choice. Tenants work side-by-side with staff to assess their current strengths and needs. Once tenants identify their goals, staff provide support and training to assist them in increasing their independence. The one goal shared by all tenants is that they will transition from this 'training setting' to a 'traditional community' apartment sometime in the next few years. Common focus areas for training include personal safety, tenant-landlord responsibilities, how to be a good neighbor, money management, health and wellness, community access, home maintenance, cooking, nutrition, and self-care.

Within the transitional apartment model, tenant supports are individualized based on goals and needs. Supports can be funded by one of the New York State Community Based Waivers (for individuals with a developmental disability, a traumatic brain injury, or acquired disability), no-fault insurance, or self-pay. Tenants are provided a safety net by having timely access to staff 24 hours per day, seven days a week. This safety net provides the individual, as well as their family and friends, with a sense of security. Tenants will develop meaningful relationships with others who are going through similar experiences. As the Happiness House model has proven, these relationships continue even after individuals have moved on to community apartments.

CP Rochester's transitional apartment building will offer seven, one-bedroom units with a large common area that includes a kitchen and recreational space. The agency is working with the Town of Henrietta for final approval of its design. CP Rochester anticipates the apartments will provide support and training for 15-20 individuals during its first 10 years of operation. Construction is expected to begin in August of 2017.

Rochester Rookies Receive Funds



Rochester Press Radio Club Children's Charities Fund awarded SportsNet \$1,000 to be used in support of the Rochester Rookies Track and Field team.

The positive, confidence-building impact the Rochester Rookies program has on children diagnosed with disabilities only continues to grow as they progress in the program. The \$1,000 gift will be used to underwrite competition related expenses, team travel, and adapted equipment transport.



DHSNY-NICIP Awards Finger Lakes United Cerebral Palsy/Happiness House \$587,942

New York State excitedly announced \$100 million in grants were awarded to 237 applicants in the state. Finger Lakes United Cerebral Palsy/Happiness House was awarded \$587,942 for capital improvements needed at their Geneva headquarters after a very competitive RFP process. Applicants were evaluated based on the scope of the proposed project, the number of clients who will benefit, how critical the project is for helping the nonprofit service its target population, how necessary the project is for allowing the nonprofit to serve a new population, as well as other factors.

The Geneva location is home to Early Intervention, Preschool, Day Care and is an Article 16 Clinic site. Most of the current HVAC system is 24 years old and beyond its "useful life." Many of the windows are cracked, do not close with a proper seal, or present opportunities for mold due to water condensation and an outdated, rusting and leaking air conditioning system. The funds we received will be used to replace the entire HVAC system and all windows throughout the building.




\$25,000 Gift from the AI Sigl Sports Committee for Various Programs

DDRO Funds Respite Recruiter

Happiness House has been awarded a Family Support Services grant through the Finger Lakes Developmental Disabilities Regional Office (DDRO). Through this initiative \$22,888/year for up to five years, will be provided to engage a part-time Respite Recruiter whose primary function will be to work closely with families residing in Ontario, Seneca, Wayne and Yates counties to recruit, interview and hire Respite staff best suited to meet their loved one’s needs. The Respite Recruiter will develop firsthand knowledge of the current roster of Respite staff, their skill attributes and availability so that timely matches can be arranged with new Respite service enrollees.

To be eligible to receive Happiness House Respite services individuals must be OPWDD eligible, reside at home with family and in need of consistent, high quality Respite services. With this additional resource Happiness House anticipates being able to serve 13 new individuals with self-directed services for whom Respite is an identified service. They also anticipate decreasing the number of families currently “waitlisted” to receive Respite services by 50% (from 20 to 10) , and decreasing the average amount of time any family must wait for this service due to lack of identified staff resources.

This award will enable Happiness House to expand delivery of a critically needed service in an underserved region of the Finger Lakes.

Understanding Where Your Gift Goes

Ability Partners Foundation supports the missions of CP Rochester, Happiness House, and Rochester Rehabilitation, so it is important to understand where monetary and in-kind gifts go once they are given by a donor.

Nearly every gift given to CP Rochester (CP), Happiness House (HH), Rochester Rehabilitation (RR), and Ability Partners Foundation (APF) benefits ALL organizations! Monies raised from the two *Galas*, the *Autism Awareness Walk*, *5K Run for Fun*, *Francis ‘Ben’ Bonafiglia Golf Tournament*, *Dash to Cash*, and *Bowling to Raise Bucks* are accepted by APF. This means, by participating in any agency event, your contribution helps **all three** agencies! Now, donors’ gifts carry a much greater impact. In addition, general gifts to CP, HH and RR throughout the year benefit all three agencies.

There are certainly exceptions to the rule. Gifts that are made to a specific program or service at an agency are reserved solely for that agency. For example, if a donor wishes to give \$1,000 to the HH Structured Day Program, Ability Partners Foundation will process the gift and only apply it to that specific program at HH. Where this is typically most prevalent is with in-kind gifts (furniture, food, etc.) but it can happen with monetary gifts as well. In order for this type of *donor designated* gift to occur, the donor must submit the request in writing when making the gift.

When writing a check to benefit CP, HH or RR, we ask you to make it out to **Ability Partners Foundation**. However, even if your check is made out to one of the agencies, it will still benefit all three (unless you designate your gift to a specific program or agency).



Ways to Give

Many donors choose to give from their immediate assets such as cash and check (or via credit card). In addition to this type of giving, there are a number of creative ways to provide long-term financial support, such as with a 'legacy' gift. The goal of the Legacy Society is to plan for our organizations' future and set the course for a strategic vision which will carry the agencies forward. Legacy gifts include bequests, charitable gift annuities, charitable remainder trusts, charitable lead trusts, life insurance, real estate, and others.

Every member of the CP Rochester (CP), Happiness House (HH) and Rochester Rehabilitation (RR) family has the power to make future change possible. Together, we continue to ensure the long-term sustainability of programs and services for the 6,650 individuals we serve each year.

Legacy Gifts

- Stocks – Gifts of stock enable donors to avoid capital gains on the appreciation in market value of the shares.
- Bequests – Simple bequests may be made through a donor's will and can specify any dollar amount, percentage, or portion of the estate.
- Charitable Gift Annuity – A charitable gift annuity is when a donor transfers property (cash, securities, real estate) to our agencies in exchange for a fixed dollar payment during the donor's lifetime.
- Charitable Gift from an IRA – Individuals over 70½ may designate direct contributions from an IRA.
- Charitable Remainder Trust – A charitable remainder trust pays income to the donor or beneficiary for a period of time, after which the property in trust passes to our agencies.
- Charitable Lead Trusts – A charitable lead (income) trust is established when a donor transfers property to a trust, which generally pays interest income to CP, HH and RR.
- Life Insurance – A gift of life insurance allows a donor to pass on part of his or her estate with minimum cost, maximum benefit, and often an estate tax advantage.
- Real Estate – Gifts of real estate include a principal residence, vacation home, farm, commercial property, and land.
